The Division will accept completion of a law degree as meeting the equivalency of the Real Estate Principles course and Real Estate Law course requirements for a real estate license in Nevada Proof of completion shall be by certified official transcript from an accredited institution

### **Real Estate Instructions for Reciprocal State Applicants**

Certification of License History: A certification of license history is required from the licensing authority in every state in which you currently hold or have held a real estate license The reciprocal state must confirm you took an examination in that state Salespersons: Your sponsoring broker must have an "Active" Connecticut license
